Charges on Cancellation of Registration:

- Before classes: Processing fee of Php300.00 plus Php5,000.00
- 1st week of classes: Processing fees of Php300.00 plus 25% of total school fees
- 2nd week of classes: Processing fee of Php300.00 plus 50% of total school fees
- 3rd week of classes and so on: Processing fee of Php300.00 plus 100% of total school fees

Charges on Late Payment of Installment Due:

- Php48.00 per late installment due (cumulative)
- After the last installment due, 5% of the balance
